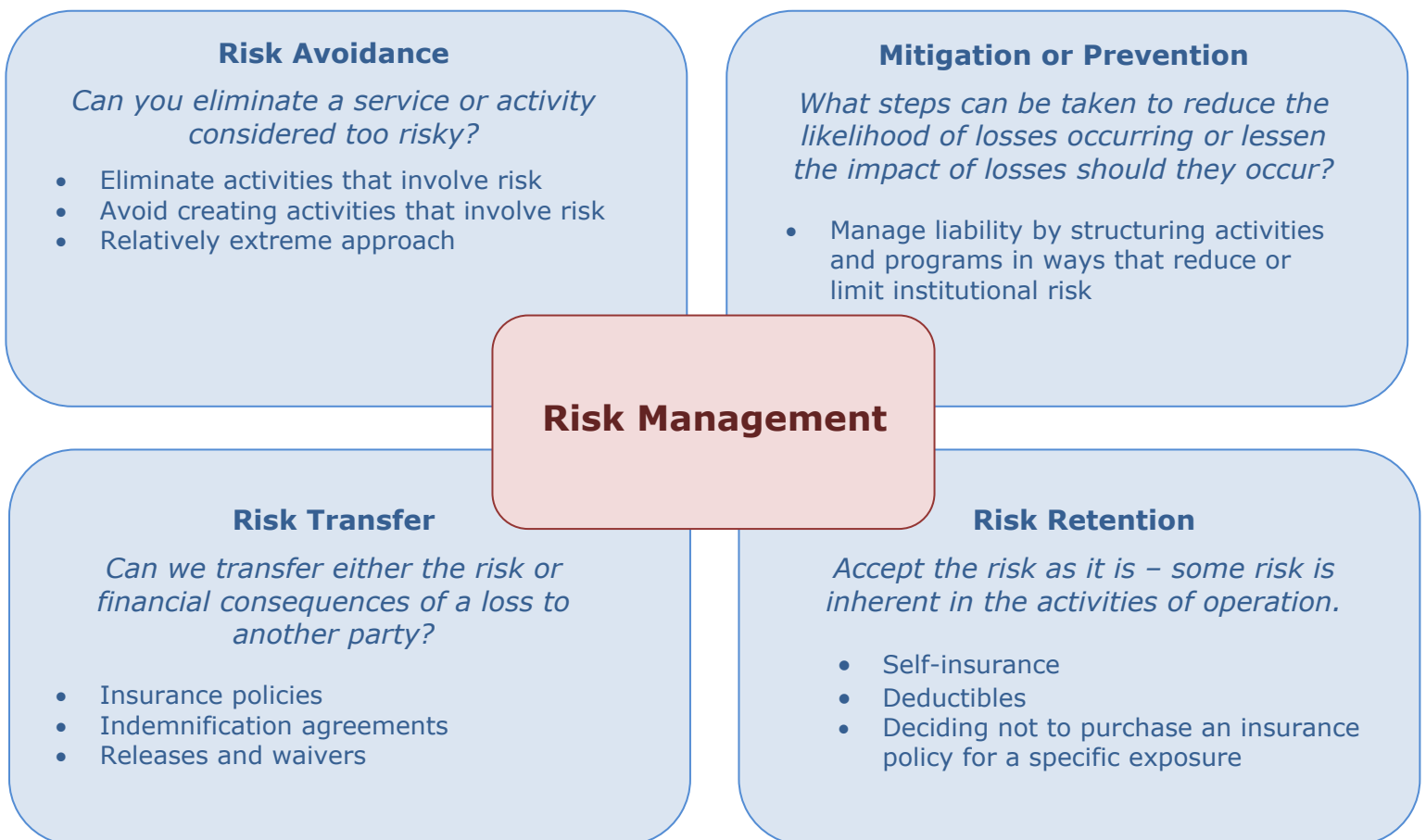


# FOUR COMPONENTS OF EFFECTIVE RISK MANAGEMENT
